This was a special meeting of the Board of Directors to address new information about sidewalk construction in Townsend Harbor.

Townsend Harbor Sidewalk

Mark Cram learned from Vanasse Hangen Brustlin, Inc. (VHB) that Route 119 improvement is not on Mass Highway's TIP list, as we previously believed, and therefore the Townsend Harbor sidewalk is not scheduled for construction.

Peter Cunningham spoke with Anne Sullivan at Mass Highway to discuss alternative approaches to the sidewalk project and plan for a site tour.

Bill Rideout will inform Town Administrator Andy Sheehan of the new developments.

Meetings with Townsend Police and Fire/EMS

Bill Rideout and Steve Meehan met with Townsend Police Chief Erving Marshall and presented a draft letter as required by DCR. Chief Marshall approved the letter with edits but expressed a preference for attending the Selectmen's meeting in person.

Chief Marshall noted that his research shows most rail trail emergency calls are medical, rather than crime related, and recommended that Bill and Steve speak to Fire and EMS Chief Donald Klein.

Chief Klein voiced no issues with the letter and also offered to attend the Selectmen's meeting.

Preparations for Townsend Board of Selectmen Meeting on Tuesday, October 23

Townsend Selectman Robert Plamonden informed us that the October 23 meeting will be open for public comment.

All Townsend board members please encourage 3-5 supporters to attend!

Families with young people would be especially helpful. Also, it's not too late for additional letters to the Selectmen.

Bill Rideout and Joan Wotkowicz will work on a second newsletter, targeted for the Tuesday prior to the meeting.

Bruce also noted that we may have an opportunity to move the gate in Bertozzi so that it blocks vehicle access to the rail trail toward the south.
