# Meeting with Townsend Historical Society Board of Directors

Bill Rideout reviewed a meeting he attended on October 30 to review our agreement over a recorded easement through Historical Society property. He discussed liability insurance with them, while reviewing with them that we are both covered by the Massachusetts recreational use statute.

The Society would like us to apply a surface at the edge of their parking lot that looks different, so drivers can identify it as the rail trail route. They also asked for details about the planned sidewalk in Townsend Harbor.

Bill represented our rail trail in a co-presentation with Colleen Abrams from Wachusett Greenways.

#### **MBTA Draft Lease**

MBTA review of the draft lease is expected to take about a month. We did not recommend any changes, which should help to expedite. After we sign, we will return the lease to MBTA for their signature.

As MBTA now has the lease from the realty company, Bill suggested we contact Mark Boyle of the MBTA directly to inquire about timing. WE discussed the idea of a publicity photo with the MBTA at the signing.

The realty company has sent a Cease and Desist letter regarding encroachment.

## **Publicity/Fundraising**

Bill spoke with Darcy Donald of Friends of Nashua River Rail Tail about fundraising. She gave suggestions but cannot join our group. Bill plans to speak with Linda Mack from Townsend.

Al Futterman reached out to three people associated with the Trustees of Reservations.

Joan Wotkowicz presented quotes from three graphic artists for designing our fundraising campaign flyer. She will get a written quote from Julia Egan. We decided to wait to have our copy evaluated before proceeding.

Bill will send around a case statement from the campaign for Mt. Watatic.
