Ray pointed out that we need to set guidelines such as how low to cut stumps, etc. Mark will set some guidelines that Ben will use to write a project plan that we will review. We will schedule a site walk before approving any work. As a courtesy, we will also inform the Town Administrator of Ben's project.

A motion to allow Ben to proceed with plans for the Eagle Scout project passed unanimously.

Event Reports

Townsend Historical Society - Bill met with the Board Feb 24 about the easement at Harbor Church. We expect them to grant an easement once we get our permits. They recommend that we meet with the Townsend Historical Commission. Also, a future option for us may be ownership of Harbor Church.

Upcoming Events

Townsend Earth Day (Saturday, April 23) - We will start our Buy-a-Brick campaign. Joan will work on a flyer with marketing info for the campaign and the URL to order. The flyer will also announce the clean-up day.

Groton River Festival (Sunday, June 19)

Trail Clearing - We will host a trail cleaning day and ask people to bring bags for trash and recycle. Don suggested we contact Shaw's to schedule a dumpster. Bruce will ask about disposal in Groton.

Tentative date: Saturday, May 14.

UPDATE: Tentative date for the clean-up has been moved to April 23 to take advantage of town-sponsored trash disposal during Earth Day.

CFNCM grant workshop (March 25) - Joan signed up to attend this workshop that is recommended for all groups who may be invited to submit full proposals.

Coalition for Recreational Trails Annual Achievement Awards - Once we build the trail, we may consider submitting for this award, which includes a category for public-private partnerships.

Fisheries and Wildlife

Bill suggested a small group meet with Pat Huckery to discuss a parking lot along the rail trail at Bertozzi, including Cedwyn, Bruce, Steve, Bill, and Al. A motion to schedule a meeting passed unanimously.

Natural Heritage and Conservation Commission Permitting

Don submitted our WPA Form 1 to Townsend Conservation Commission. As a non-profit, we will ask for a waiver of their fee for appearing at the commission. A copy was also sent to DEP.

We are scheduled to meet with the commission at 8:15 P.M. in Town Hall on Wednesday, March 23. A site walk is expected to be scheduled.

A motion to approve \$71.60 payment for the permit application passed unanimously.

Capital Campaign/Publicity/Outreach

Buy-a-Brick campaign - Bill showed a sample engraved brick. Our Earth Day flyer will announce the campaign launch.

"Coming Soon" signage - Postponed for next meeting.
